General

Sharjah National Oil Corporation (Contractor) is seeking expressions of interest (EOI's) from qualified suppliers to provide **MILD STEEL PLATES** for the **Moveyeid Gas Storage Surface Facility Project**. The selected supplier will be required generally to supply, design/fabricate and test the equipment/instruments/materials in compliance with Moveyeid Gas Storage Surface Facility Project - SHARJAH requirements.

The purpose of this EOI is to develop a list of suppliers that are interested in providing the equipment/instruments/materials or services required by the Project in order to begin the prequalification process. Once EOI responses are received from suppliers interested in performing the work described below, they will be evaluated by Sharjah National Oil Corporation (Contractor) review team. Based on the evaluation of the data requested in this EOI, a recommendation will be made to move forward with the prequalification process.

Suppliers shall be initially responsible for any expenses incurred in responding to this EOI, the terms of which are subject to change or cancellation by Sharjah National Oil Corporation at any time. Notwithstanding the nature or content of responses received, Sharjah National Oil Corporation is not under any obligation to add a supplier to a Bidders List, to proceed with an invitation to tender (ITT) or to award a contract to any supplier with respect to the services described in this EOI.



Project Overview

The project comprises of new high pressure compressor facility, a high pressure pipeline and Flow lines to 4 existing wells in Moveyeid Field. The value of the scope of work is circa \$40 Million. Additional project scope also includes drilling horizontal legs in existing wells and Potentially drilling new wells in 2023.

It will be operated in a fully automated mode with world-class technical and safety standards.

The projected infrastructure will be designed to allow future expansion.

The mentioned project will be a major new business development activity for SNOC. It will Allow us to store excess gas in the winter to satisfy the summer peak demand as well as Provide a readily available strategic reserve for energy security allowing us to respond to Unexpected operational or market issues.

All Instruments/equipment/materials shall be certified to the Emirates Authority for Standardization and Metrology and the UAE Ministry of Energy and Infrastructure.



Supplier's scope of supply also includes:

Schedule

SNOC plans to issue Request for Quotes in 1st quarter of 2022 to suppliers interested with a potential award to the successful bidder in 1st quarter of 2022. The equipment/instrument/materials is scheduled to be delivered by the 2nd quarter of 2022.

EOI applications or responses without the proof of payment (Swift copy) showing the EOI Refundable Application Deposit amount of US\$ 15,075.00 = 55,363AED paid to SNOC's Nominated Custodian will be deemed incomplete and not subject to evaluation.

We vividly state that the EOI application deposit is refundable within a maximum of twenty-one (21) days from the submission deadline to applicant whether successfully short-listed or disqualified.

We shall provide applicants with an Invoice containing the banking coordinates of SNOC's Nominated Custodian and a Declaration Letter from SNOC covering the proposed refundable EOI application deposit.

The Refundable EOI Application deposit is required to determine level of interest of applicant towards bidding for the service(s) and to protect the company against any unethical conduct by the applicant during the selection process.

The Refundable EOI Application deposit shall be fully refunded to the Applicant's provided bank account within a maximum of twenty-one (21) days from the submission deadline to applicant whether successfully short-listed or disqualified.



Supplier Details

Suppliers interested in performing the work or supplying the product and services shall provide details and evidence for the following:

a) Safety:

- ☐ A record of the number of hours worked annually for the past three years, together with the number of restricted work cases, lost time injuries and fatalities experienced.
- ☐ Health, Safety and Security Management System

b) Quality Management System:

- ☐ Copy of certificate of registration to ISO, ASME or Equivalent. The ISO certificate of registration must be accompanied with a list of exemptions, if any, taken to ISO.

c) Financial:

- ☐ Financial statements and balance sheets for the past two years.
- ☐ The supplier's name and corporate structure including any proposed joint venture partner (or equivalent arrangement), together with relevant contact information.
